The 1st of you as principal borrower and 2nd of as guarantor/co-obligant/co-borrower/mortgagor availed Commercial Vehicle (CV) Loan with number 17676900000215 of ₹29,52,397/- (Rupees Twenty Nine Lakh Fifty Two Thousand Three Hundred Ninety Seven only) on 29/10/2021 from the Federal Bank Limited, a company registered under the Companies Act, having its registered office at Aluva, Kerala **through its branch at Pune/Shivane** (hereinafter referred to as 'the bank').
