Whereas the borrowers having failed to repay the amount within the stipulated time, the Authorized Officer on behalf of the Federal Bank Ltd. has taken possession of the security property described herein below in exercise of powers conferred under section 13(4) of the said Act read with Rule 8 of the said Rules on 20.01.2024 by issuing notices to the borrowers/defaulters and public, and publication thereof in newspapers as contemplated under the said Act and Rules.

The undersigned being the Authorized Officer of the Bank hereby give notice to the borrowers and general public that the Bank has decided to sell the property described herein below on the 08.04.2025 on "AS IS WHERE IS" "AS IS WHAT IS" and "WHATEVER THERE IS" basis under Rules 8 & 9 of the said Rules for realising the sum of ₹ 1,56,73,620.10 (Rupees One Crore Fifty Six Lakh Seventy Three Thousand Six Hundred Twenty Paise Ten Only) as on 18.03.2025 under the Term Loan -Home invest with further interest, cost and other charges till realization and thus the

undersigned being the Authorised Officer of the Bank hereby invites from interested parties, the sealed tenders for purchasing the property subject to the terms and conditions mentioned hereunder.

DESCRIPTION OF THE IMMOVABLE PROPERTY
