NOTICE FOR SALE OF SECURITY PROPERTIES ISSUED UNDER THE SECURITISATION AND RECONSTRUCTION OF FINANCIAL ASSETS AND ENFORCEMENT OF SECURITY INTEREST ACT 2002, (hereinafter referred to as Act) r/w SECURITY INTEREST (ENFORCEMENT) RULES, 2002 (hereinafter referred to as Rules).

Whereas

Whereas the borrowers having failed to repay the amount within the stipulated time, the Authorized Officer on behalf of the Federal Bank Ltd has taken possession of the security properties described herein below in exercise of powers conferred under section 13(4) of the said Act read with Rule 8 of the said Rules on **02/09/2023** by issuing notices to the borrowers/defaulters and general public and publication thereof in newspapers as contemplated under the said Act and Rules.

The undersigned hereby give notice to the borrowers and general public that the Bank has decided to sell on **16th day of May, 2025** the properties described herein below on "AS IS WHERE IS", "AS IS WHAT IS", and "WHATEVER THERE IS" basis under Rules 8 & 9 of the said Rules for realizing the dues of **₹1,30,98,934/- (Rupees One Crore Thirty Lakh Ninety Eight Thousand Nine Hundred and Thirty Four only)** made up of (a) ₹1,10,89,031/- (Rupees One Crore Ten Lakh Eighty Nine Thousand and Thirty One only) under your Cash Credit limit, (b) ₹10,47,208/- (Rupees Ten Lakh Forty Seven Thousand Two Hundred and Eight only) under your GECL-1 loan account and (c) ₹9,62,695/- (Rupees Nine Lakh Sixty Two Thousand Six Hundred and Ninety Five only) under your GECL-2 loan account as on **24/04/2025** with further interest, cost and other charges and thus the undersigned being the Authorised Officer of the Bank hereby invites from interested the sealed tenders for purchasing the properties subject to the terms and conditions mentioned hereunder.
