The undersigned being the Authorised Officer of the Bank hereby give notice to the borrowers and general public that the Bank has decided to sell the property described herein below on the **05.07.2025** on "AS IS WHERE IS" "AS IS WHAT IS" and "WHATEVER THERE IS" basis under Rules 8 & 9 of the said Rules for realising the sum of ₹ **98,28,441.63** (Rupees Ninety Eight Lakh Twenty Eight Thousand Four Hundred Forty One Paise Sixty Three Only) as on 13.06.2025 [ Dues as per OA number 288/2023 before Hon'ble DRT ] under the Federal Housing Loan and asset guard Loan together with further interest, cost and other charges till realization and thus the undersigned being the Authorised Officer of the Bank hereby invites from interested parties, the sealed tenders for purchasing the property subject to the terms and conditions mentioned hereunder

## **DESCRIPTION OF THE IMMOVABLE PROPERTY**

All the piece and parcel of the landed property measuring 6.07 Ares along with right of way residential building and all other improvements consists of (a) 4.45 Ares in Resy no.143/5-7 and (b)

1.62 ares in re-Sy no 143/5 block 05 (old Sy no 327/3A/1, 3B/11, 3A,3B) situated in Parakadavu village, Aluva taluk, Ernakulam district, Kerala state and bounded as per title deed on east by: property of karukambilly Janaki and Sulochana, south by: canal road, west by: 8 ft wide private path and north by: property of kalanthamparambil Raju.
