- a. The reserve price below which the property will not be sold is as mentioned above.
- b. The intending purchasers shall submit /send to the undersigned their tender quoting the price offered by them in a sealed cover along with a Demand Draft favouring The Federal Bank Ltd. payable at Chennai for Rs.3,40,000/- (Rupees Three Lakhs and Forty Thousand Only) being earnest money equivalent to 10 % of the Reserve Price for each of the properties mentioned above as item 1 and 2, which is refundable if the tender is not accepted. Bids shall be submitted in the multiples of Rs.25,000/- over and above the reserve price.
- c. Tenders in respect of each item of the property along with the demand draft for earnest money shall be submitted separately. The Tenders which are not duly sealed and are not accompanied by Demand Draft as afore stated will be summarily rejected.
