NOTICE FOR SALE OF SECURITY PROPERTIES ISSUED UNDER THE SECURITISATION AND RECONSTRUCTION OF FINANCIAL ASSETS AND ENFORCEMENT OF SECURITY INTEREST ACT 2002, (hereinafter referred to as Act) r/w SECURITY INTEREST (ENFORCEMENT) RULES, 2002 (hereinafter referred to as Rules).

Whereas The Federal Bank Ltd (hereinafter referred to as 'the Bank') through its Authorised Officer under the Act issued a Demand Notice dated 05-07-2018, calling upon the borrowers namely (1) M/s AMES Foods Processors India Pvt. Susan Paulose, 311-South, 295<sup>th</sup> Place, Federal Way, Washington State, 98003, USA to repay the amount mentioned in the notice being ₹ 30,07,18,603/- (Rupees Thirty Crore Seven Lakh Eighteen Thousand Six Hundred and Three Only) being the amount due under the credit facilities availed from Ernakulam/North branch together with interest and costs and other charges within 60 days from the date of the said notice.

Whereas the borrowers having failed to repay the amount within the stipulated time, the Authorized Officer on behalf of the Federal Bank Ltd. has taken possession of the security properties described herein below in exercise of powers conferred under section 13(4) of the said Act read with Rule 8 of the said Rules on 08-12-2021 by issuing notices to the borrowers/defaulters and public, and publication thereof in newspapers as contemplated under the said Act and Rules.

The undersigned being the Authorised Officer of the Bank hereby give notice to the borrowers and general public that the Bank has decided to sell the property/ies described herein below on the **06**<sup>th</sup> **day of May 2025** on "AS IS WHERE IS" "AS IS WHAT IS" and "WHATEVER THERE IS" basis under Rules 8 & 9 of the said Rules for realising the sum of ₹ **91,62,17,580/-(Rupees Ninety One Crore Sixty Two Lakh Seventeen Thousand Five Hundred and Eight Only) as on <b>24-03-2025** under the credit facilities availed by 1<sup>st</sup> to 3<sup>rd</sup> of you, as per the claim in OA-208/2020 filed before DRT-1,Ernakulam and thus the undersigned being the Authorised Officer of the Bank hereby invites from interested parties, the sealed tenders for purchasing the property/ies subject to the terms and conditions mentioned hereunder.

### (I) <u>Description of Mortgaged Immovable Property</u>

# **Terms and Conditions**

- 1) The property/ies and machineries described above as Item No (I) and (II) will be sold as single lot and the **reserve price** below which the properties will not be sold is ₹ 15,25,00,000/- (Rupees Fifteen Crore Twenty Five Lakh Only).
- 2) The intending purchasers shall submit /send to the undersigned their tender quoting the price offered by them in a sealed cover along with a Demand Draft favoring The Federal Bank Ltd. payable at Ernakulam or by RTGS/NEFT for ₹ 1,52,50,000/-(Rupees One Crore Fifty Two Lakh and Fifty Thousand Only) being earnest money deposit (EMD) equivalent to 10% of the Reserve Price of the property, which is refundable if the tender is not accepted. The Demand Draft for EMD shall be sent/

- handed over to the undersigned separately along with the envelope containing the tender under acknowledgement.
- 3) Tenders which are not duly sealed and are not accompanied by Demand Draft/RTGS/NEFT as afore stated will be summarily rejected.
- 4) The sealed covers containing tender shall reach the undersigned **before 05.00 PM** on **05-05-2025**.
- 5) The intending purchasers / their authorized representatives shall be present along with valid photo identity proof before the undersigned at his office on **06-05-2025** at **11.00 AM** when the tenders will be opened. In case where the tender is submitted by an incorporated Company/Partnership/Association/Trust, the person representing such company/ Partnership/Association/Trust shall produce true copy of resolution/authorization from the company/Partnership/Association/Trust.
- 6) After opening tenders, the intending bidders may be given opportunities at the discretion of the Authorized Officer to have inter-se bidding among themselves to enhance the offer price. Bidders shall improve their offer by a multiple Rs.1,00,000/-(Rupees One Lakh Only).
- 7) The successful bidder shall deposit 25% of the bid amount / sale price (inclusive of EMD) immediately on acceptance of his tender/ offer by the Bank and the balance 75% within 15 days or such further time as permitted by the authorized officer in accordance with law, failing which the entire deposit inclusive of EMD made by him / her / them shall be forfeited without any notice and the property concerned will be resold.

- (iii) On payment of fees and submission of documents, Agreement shall be executed.
- (iv) Registration of Sale Deed in the name of new party.
- 11) Total dues with regard to CFC and Water charges is Rs.17,42,521/- which shall be remitted to KINFRA park, as informed by KINFRA. No other encumbrance or charge in respect of the property has come to the notice of the Bank. The Bank will not be held responsible for any charge, lien, encumbrance, property tax or any other dues to the Government or anybody in respect of the property under sale.
