NOTICE FOR SALE OF IMMOVABLE PROPERTY ISSUED UNDER THE SECURITISATION AND RECONSTRUCTION
OF FINANCIAL ASSETS AND ENFORCEMENT OF SECURITY INTEREST ACT 2002, (hereinafter referred to as Act)

Whereas The Authorized Officer of the Federal Bank Ltd. under the Act issued a demand notice dated 03/07/2021 calling upon the borrower(s) and / or guarantor (s) and / or defaulters 1. Sri. Gopinath M S/o Murugan K and 2. Smt. Priyanka G W/o Gopinath M, both are residing at No 649/6, Bharathi Nagar, Renganathapuram, Nandambakkam, Chennai 600069, to pay the amount mentioned in the notice being ₹63,71,798/- (Rupees Sixty-Three Lakhs Seventy-One Thousand Seven Hundred and Ninety-Eight only) consisting of a) ₹62,63,880/- under the Term Loan (Federal Housing Loan) Account No 15217300000323 and b) ₹1,07,918/- under the Term Loan (Asset Guard) Account No 15217600001096 within 60 days from the date of receipt of the said notice.

Whereas the borrower(s) and / or guarantor (s) and / or defaulters having failed to repay the amount within the stipulated time, the authorized officer on behalf of the Federal Bank Ltd. has taken possession of the property described herein below in exercise of powers conferred under section 13(4) of the said Act read with Rule 8 of the said Rules on 21.12.2021 by issuing a notice to the borrowers/defaulters and general public and publication thereof in newspapers as contemplated under the said Act and Rules.

The undersigned hereby give notice to the borrower(s) and / or guarantor (s) and / or defaulters and general public that the Bank has decided to sell on 30th April 2024 the property described herein below on " As is where is", "As is what is" and "Whatever there is " under Rules 8 & 9 of the said Rules for realizing the dues totaling to a sum of ₹83,55,271.41 (Rupees Eighty-Three Lakhs Fifty-Five Thousand Two Hundred Seventy-One and paise Forty-One only) as on 30-04-2024 as per the claim in the OA filed before DRT-2, Chennai consisting of a) ₹82,04,800.20/- under the Term Loan (Federal Housing Loan) Account No 15217300000323 and b) ₹1,50,471.21/- under the Term Loan (Asset Guard) Account No 15217600001096 and interest thereon and thus the undersigned hereby invites from interested parties the sealed tenders for purchasing the property subject to the terms and conditions mentioned hereunder.

DESCRIPTION OF THE PROPERTY

All that piece and parcel of Residential Flat bearing Flat No S2, on the Second Floor, Block A, having a super build up area of 1163 Sq. feet including the common area along with one covered car parking together with an undivided share of 582 Sq. ft of land in and out of 5040 Sq. Ft of land situated at Nellaiyappar 1st Street, Bharathipuram, Nemilichery Village, Chrompet, Pallavaram Taluk (Previously Alandur Taluk), Chengalpatu district, Chennai 600044.

Terms and Conditions

- a. The reserve price below which the property will not be sold is Rs.58,00,000/- (Rupees Fifty-Eight Lakhs only).
- b. The intending purchasers shall submit /send to the undersigned their tender quoting the price offered by them in a sealed cover along with a Demand Draft favoring The Federal Bank Ltd. payable at Chennai for Rs.5,80,000/- (Rupees Five Lakhs and Eighty Thousand Only) being earnest money equivalent to 10 % of the Reserve Price of the property concerned, which is refundable if the tender is not accepted.
- c. Tenders in respect of each item of the property along with the demand draft for earnest money shall be submitted separately. The Tenders which are not duly sealed and are not accompanied by Demand Draft as afore stated will be summarily rejected.
