The Federal Bank Ltd (hereinafter referred to as 'the Bank') through its Authorised Officer under the Act issued a Demand Notice dated **04/11/2019**, calling upon the borrower namely, Sri Senish Sebastian, S/o Sebastian, Paickattu House, 75 B, Koothattukulam, Ernakulam − 686 662, to repay the amount mentioned in the notice being ₹46,74,911/-(Rupees Forty Six Lakh Seventy Four Thousand Nine Hundred and Eleven only) made up of ₹42,26,201/ (Rupees Forty Two Lakh Twenty Six Thousand Two Hundred and One only) in the CC Contractors Plus account and ₹4,48,710/- (Rupees Four Lakh Forty Eight Thousand Seven Hundred and Ten only) in the Term Loan account with further interest, due under the limits/ loans availed from Koothattukulam branch of the Bank, together with interest and costs and other charges within 60 days from the date of the said notice.

Whereas the borrowers having failed to repay the amount within the stipulated time, the Authorized Officer on behalf of the Federal Bank Ltd. has taken possession of the security property described herein below in exercise of powers conferred under section 13(4) of the said Act read with Rule 8 of the said Rules on 23/12/2021 by issuing notices to the borrowers/defaulters and public, and publication thereof in newspapers as contemplated under the said Act and Rules.

The undersigned being the Authorised Officer of the Bank hereby give notice to the borrowers and general public that the Bank has decided to sell the property described herein below on the **09/05/2025** on "AS IS WHERE IS" "AS IS WHAT IS" and "WHATEVER THERE IS" basis under Rules 8 & 9 of the said Rules for realising the sum of ₹1,20,84,509/- (Rupees One Crore Twenty Lakh Eighty Four Thousand Five Hundred and Nine only) made up of ₹1,10,69,676/ (Rupees One Crore Ten Lakh Sixty Nine Thousand Six Hundred and Seventy Six only) in the CC Contractors Plus account and ₹10,14,833/- (Rupees Ten Lakh Fourteen Thousand Eight Hundred and Thirty Three only) in the Term Loan account as on **15/04/2025** together with further interest, cost and

other charges till realization and thus the undersigned being the Authorised Officer of the Bank hereby invites from interested parties, the sealed tenders for purchasing the property subject to the terms and conditions mentioned hereunder.

DESCRIPTION OF THE IMMOVABLE PROPERTY

All the piece and parcel of the landed property measuring 20.33 Ares with all improvements thereon comprised of (a) 8.89 Ares as per the title deed in Sy No.573/5A/1, (b) 10.04 Ares in Sy No.573/5B, (c) 1.11 Ares in Sy No.573/5A/1 and (d) 0.29 Ares in Sy No.573/5B situated in Koothattukulam Village, Muvattupuzha Taluk, Ernakulam District, Kerala State and bounded as per title deed for (a) 8.89 Ares as per the title deed in Sy No.573/5A/1 and (b) 10.04 Ares in Sy No.573/5B on the East by Property of Seljo and Senish, West by Property of Subhadra Nirappel, North by Private Way and South by Private Road and bounded as per title deed for (c) 1.11 Ares in Sy No.573/5A/1 and (d) 0.29 Ares in Sy No.573/5B on the East by Panchayath Road, West by Property of Sebastian, North by Property of Senish and South by Property of Sebastian.
