Whereas the borrower(s) and / or guarantor (s) and / or defaulters having failed to repay the amount within the stipulated time, the authorized officer on behalf of the Federal Bank Ltd. has taken possession of the properties described herein below in exercise of powers conferred under section 13(4) of the said Act read with Rule 8 of the said Rules on 13/11/2019 by issuing a notice to the borrowers/defaulters and general public and publication thereof in news papers as contemplated under the said Act and Rules.

The undersigned hereby give notice to the borrower(s) and / or guarantor (s) and / or defaulters and general public that the Bank has decided to sell on **10th February 2022** the property described herein below on *“AS IS WHERE IS” “AS IS WHAT IS” and “WHATEVER THERE IS”* under Rules 8 & 9 of the said Rules for realizing the total dues of **₹ 48,71,711.02 (Rupees Forty Eight Lakhs Seventy One Thousand Seven Hundred and Eleven and paise Two only]** as on date of sale with further interest, cost and other charges till realization and thus the undersigned hereby invites from interested parties the sealed tenders for purchasing the property subject to the terms and conditions mentioned hereunder.

DESCRIPTION OF THE PROPERTY

All the piece and parcel of land having a total extent of 2.43 Ares along with residential building bearing No. 844, ward 9 of Mayyanad Grama Panchayath therein comprised in Re. Sy No. 432/14/1/4, Block No. 27, Mayyanad Village, Kollam Taluk, Kollam District, Kerala State bounded on East by road, on West by property of Jeseentha Denkan, on North by property of Alphonso and on South by property of Ashraf V.T. (as per location sketch) and more fully described under Sale Deed No. 1977/2016 dated 04/08/2016 of Kottiyam SRO.

1. The property described above will be sold on *“AS IS WHERE IS” “AS IS WHAT IS” and “WHATEVER THERE IS”* basis and the property will be sold for an amount **above the reserve price of ₹ 35,28,000/- (Rupees Thirty Five Lakhs Twenty Eighty Thousand only)**.
2. The intending purchasers shall submit/send to the undersigned their tender quoting the price offered by them (**the amount quoted shall be above the reserve price fixed**) in sealed cover along with a Demand Draft/ Proof of RTGS of **₹ 3,52,800/- (Rupees Three Lakhs Fifty Two Thousand only)** favoring The Federal Bank Ltd. payable at Mavelikkara/RTGS Account – Current Account General, A/c No. 20352200000017, IFSC – FDRL0002035, Pooyappally Branch, the earnest money deposit (EMD) equivalent to 10% of the Reserve Price of the property, which is refundable if the tender is not accepted.
