NOTICE FOR SALE OF IMMOVABLE PROPERTY ISSUED UNDER THE SECURITISATION AND RECONSTRUCTION OF FINANCIAL ASSETS AND ENFORCEMENT OF SECURITY INTEREST ACT 2002, (Hereinafter referred to as Act) R/w SECURITY INTEREST (ENFORCEMENT) RULES, 2002 (hereinafter referred to as Rules).

Whereas the Authorized Officer of the Federal Bank Limited, under the Act, issued a demand notice dated 18/04/2023, calling upon the borrowers and defaulters, (1) Mr. Prashant C Waghmare alias Prashant Chandrakant Waghmare, Son of Mr. C R Waghmare and (2) Mrs. Shweta Prashant Waghmare alias Shweta Arjun Manchekar, Wife of Mr. Prashant C Waghmare, both residing at B/19, Shafi Sagar CHS, Rajaram Tawade Marg, Near Padma Gas Agency, Mhatre Wadi, Dahisar West, Mumbai – 400068 to repay the amount mentioned in the notice being Rs.88,28,855.41 (Rupees Eighty Eight Lakhs Twenty Eight Thousand Eight Hundred Fifty Five and Paisa Forty One Only) together with further interest thereon with monthly rests and costs till date of payment being the amount due under various credit facility availed by them from our Branch: Mumbai – Borivili within 60 days from the date of the said notice.

Whereas the borrower's having failed to repay the amount within the stipulated time, the Authorized Officer on behalf of the Federal Bank Limited has taken physical possession of the property described herein below in exercise of powers conferred under section 13(4) of the said Act read with rule 8 of the said Rules on 22nd day of January 2025 by issuing a notice to the borrowers and general public and publication thereof in newspapers as contemplated under the said Act and Rules.

The undersigned hereby give notice to the borrowers/defaulters and general public that the Bank has decided to sell on 10/06/2025, the property described herein below on "AS IS WHERE IS" "AS IS WHAT IS" & "WHATEVER THERE IS" basis under Rules 8 & 9 of the said Rules for realizing the dues of Rs. 1,04,46,120.41 (Rupees One Crore Four Lakhs Forty Six Thousand One Hundred Twenty and Paisa Forty one Only) as on 10/06/2025 along with further interest, charges and cost thereon from 11/06/2025 due from the borrowers under various credit facilities with Branch: Mumbai / Borivili of The Federal Bank Limited and thus the undersigned hereby invites tenders/e-bids from interested parties for purchasing the property subject to the terms and conditions mentioned hereunder.

"While we call upon you to discharge your liability as above by payment of the entire dues to the Bank together with applicable interest, all costs, charges and expenses incurred by the bank till repayment and redeem the secured asset, within the period mentioned above, Please take important note that as per section 13(8) of the SARFAESI Act 2002, (as amended), the right of redemption of secured asset will be available to you only till the date of publication of notice for publication or inviting tenders from public or private treaty for transfer by way of lease, assignment or sale of the secured asset."

Description of Property

All the piece and parcel of the Residential Flat No.19, admeasuring 605 Sq.fts built up area, on the 4th floor, together with building existing and/or to be constructed and all other improvements thereon in B wing, Shafi CHSL, situated at C.T.S No. 795 in Revenue Village – Dahisar, Rajaram Tawade Marg, Mhatre Wadi, Dahisar (West), Mumbai – 400068, , Taluka Borivali, Mumbai Suburban district, State Maharashtra, within Municipal Corporation of Greater Mumbai and within the limits of Sub-registrar Borivali, Mumbai Suburban and bounded on East by Raviraj Tarang, on the West by Rangnath Kasarkar Road, on the North by Rajaram Tawade Marg and on the South by Building.

1. The Reserve price below which the property will not be sold is Rs.81,70,000/- (Rupees Eighty-one Lakhs and Seventy Thousand Only).
2. The property will be sold by e-auction through the Bank's approved service provider M/S E-Procurement Technologies Ltd. – Auction Tiger on 10/06/2025 between 11.30 AM to 1.30 PM under the supervision of the Authorised officer of the Federal Bank Limited.

6. The EMD shall be remitted through EFT/NEFT/RTGS to the Federal Bank account no. A/c No 14030051030001, IFSC Code No. FDRL0001403 as mentioned above for Rs.8,17,000/- (Rupees Eight Lakhs Seventeen Thousand Only), before 3.00 PM on 09/06/2025, being earnest money deposit (EMD) equivalent to 10% of the Reserve Price of the property, which is refundable if the tender is not accepted.
7. The incremental Bid amount will be in the multiple of Rs.10,000.00 (Rupees Ten Thousand Only). The successful bidders shall deposit 25% of the bid amount / sale price (less EMD) immediately on acceptance of his tender/ offer by the Bank and the balance 75% within 15 days, failing which the entire deposit made by him shall be forfeited without any notice and the properties concerned will be re-sold.
