Whereas the Borrower(s)/guarantor(s) having failed to repay the amount within the stipulated time, the undersigned on behalf of The Federal Bank Ltd. has taken possession of the properties described herein below in exercise of powers conferred under section 13(4) of the said Act read with rule 8 of the said Rules on **30/06/2024** by issuing a notice to the borrowers / guarantors / defaulters and general public and publication thereof in news papers as contemplated under the said Act and Rules.

The undersigned hereby gives notice to the borrower(s) and/or guarantor(s) and/or defaulters and general public that the Bank has decided to sell on **30/07/2025** the properties described herein below on "AS IS WHERE IS, AS IS WHAT IS & WHATEVER THERE IS BASIS" under Rules 8 & 9 of the said Rules for realising an amount of **Rs. 4,56,49,629.25 (Rupees Four Crore Fifty Six Lakh Forty Nine Thousand Six Hundred Twenty Nine and Paise Twenty Five Only) (Balance outstanding calculated as per claim amount in O.A. no. 974/2022 filed before DRT-II, Ahmedabad)** due from you with further interest and costs/other charges and thus the undersigned hereby invites from interested parties sealed tenders for purchasing the properties subject to the terms and conditions mentioned hereunder.

All that piece and parcel of Plot no. 1148, admeasuring 72.00 Sq. mts. along with all the construction thereon, in scheme known as Narayan Avenue Society, situated on land bearing Revenue Survey no. 50+51/P, at Village: Bholav, Taluka and Dist: Bharuch, Gujarat. Bounded in East by Internal Road, West by Common Plot, North by Plot no. 1149 and south by Plot no. 1147/1.

1. The Reserve price below which the property will not be sold for is Rs. 33,10,000.00 (Rupees Thirty Three Lakh Ten Thousand Only).

6. The intending purchasers shall remit the EMD through NEFT/RTGS to The Federal Bank Ltd. Account No. 14702200000029, IFSC Code No. FDRL0001470, or DD drawn in favour of The Federal Bank Ltd, payable at Ahmedabad, for Rs. 3,31,000/- (Rupees Three Lakh Thirty One Thousand Only), before 4:00pm on 29/07/2025, being earnest money deposit (EMD) equivalent to 10% of the Reserve Price of the property, which is refundable if the tender is not accepted.
7. The incremental Bid amount will be in the multiple of Rs. 10,000.00 for the property.
