Whereas the borrowers having failed to repay the amount within the stipulated time, the Authorized Officer on behalf of the Federal Bank Ltd. has taken possession of the security property described herein below in exercise of powers conferred under section 13(4) of the said Act read with Rule 8 of the said Rules on **09/12/2021** by issuing notices to the borrowers/defaulters and public, and publication thereof in newspapers as contemplated under the said Act and Rules.

DESCRIPTION OF THE IMMOVABLE PROPERTY

All the piece and parcel of the landed property measuring **10.12 Ares** with all improvements thereon comprised in Re Sy No. 109/6A/3, 109/6B/4 of Kottappady Village, Kothamangalam Taluk, Ernakulam District, Kerala State and bounded on East by Panchayath Road and private way, West by Property of Chanchal, North by Property of Vijayan, and South by private way.

Terms and Conditions

- The properties described above will be sold as single lot on "AS IS WHERE IS" "AS IS WHAT IS" and "WHATEVER THERE IS" basis and the properties will be sold for an amount above the Reserve price of ₹22,00,000/- (Rupees Twenty Two Lakh only)
