The Authorized Share Capital is Rs. 800,00,00,000 (Rupees Eight Hundred Crore only) comprising 400,00,00,000 equity shares of face value of Rs. 2/- each. During the year, the Bank has issued 104,846,394 equity shares of Rs. 2/- each for cash pursuant to a preferential allotment at Rs. 87.39/- per share which resulted in an increase of Rs. 20.97 Crore in Share Capital and Rs. 894.77 Crore (net of share issue expenses Rs. 0.51 Crore) in Share premium account.

Further, the Bank has allotted 15,47,231 equity shares of Rs. 2/- each consequent to exercise of Employee Stock Option Scheme which resulted in an increase of 0.31 crore in Share Capital and 9.08 Crore in Share premium account.

The abovementioned rights shares have not been allotted and hence no dividend is due. The rights to dividend pertaining to the above-mentioned bonus shares and original holding are under abeyance due to Court injunction and other reasons;

10. Declaration/ payment of dividend; transfer of unpaid/ unclaimed dividend/other amounts as applicable to the Investor Education and Protection Fund in accordance with section 125 of the Act;

The Bank had declared a dividend of 35% i.e. Rs. 0.7 per equity share on the face value of Rs. 2/each for the financial year ended 31^{st} March, 2021. The Bank has recommended a dividend of 90% i.e. Rs. 1.80 per Equity Share on face value of Rs. 2/- each for the year 2021-22 subject to the approval of the members in the ensuing Annual General Meeting to be held on Wednesday, July 23^{rd} 2022.

In accordance with Section 125 of the Act, 1,55,899 equity shares of 182 members were transferred to Demat Account of IEPF Authority and the unclaimed/unpaid dividend for the year

2013-14 amounting to Rs. 10,023,822/- which remained unpaid and unclaimed for a period of 7 years has been transferred to the IEPF.

- 11. Signing of audited financial statement as per the provisions of section 134 of the Act and report of directors is as per sub sections (3), (4) and (5) thereof;
- 12. Constitution/ appointment/ re-appointments/ retirement/ filling up casual vacancies/ disclosures of the Directors, Key Managerial Personnel and the remuneration paid to them;

The Board of Directors of the Bank is duly constituted. The appointment and re-appointment and appointment of Director, liable to retire by rotation were made in compliance with the provisions of the Act.

During the year Mr. Shyam Srinivasan, MD & CEO of the Bank who is Key Managerial Personnel was reappointed as MD & CEO of the Bank for a period of three years w.e.f. September 23, 2021 till September 22, 2024.

Mr. Ashutosh Khajuria (DIN: 05154975) resigned from the position of Chief Financial Officer on May 18, 2021 and on the same day Mr. Venkateswaran Venkatraman (DIN: 09227554) was appointed in his place.

Mr. Ashutosh Khajuria (DIN: 05154975), Executive Director of the Bank, was re-appointed as Executive Director of the Bank for a period of one year with effect from May 01, 2022 till April 30, 2023 with the approval of Reserve Bank of India.

Ms. Varsha Vasant Purandare (DIN: 05288076) was regularized and appointed as the Director of the Bank with effect from July 09, 2021.

Mr. Balakrishnan Krishnamurthy (DIN: 00034031) Independent Director of the Bank, retired from the Directorship of the Bank effective from September 24, 2021, upon completion of his tenure as Independent Director.

Mr. Ramanand Mundkur (DIN: 03498212) and Mr. Sankarshan Basu (DIN: 06466594) were appointed as Additional Directors of the Bank with effect from October 01, 2021.
